Dissertation: Post-Occupation Obligations under the Law of Belligerent Occupation?

The dissertation explores the issue of whether international law of belligerent occupation encompasses, or should evolve to encompass, some form of post-occupation duties upon a former occupier. This legal question arises because of a lack of "fit" between the basic paradigm of occupation underpinning the law of belligerent occupation and situations of occupation that arise in the contemporary world that are not easily assimilated to the structure of belligerent occupation law. The dissertation concludes, however, that the law of belligerent occupation does not create an on-going regime of post-occupation duties falling upon the former occupier. To fill in the vacuum, a "transitional post-occupation obligations" model is proposed, grounded not in other bodies of law, but in the law of belligerent occupation itself, which should be triggered under certain circumstances when the end of occupation is approaching and gaps in essential governance and civilian protection at issue.
